## **Materials**

You do not need to purchase any materials for the course. Readings will be made available to you through LearningSuite. Any software that we use is free and available on any modern computer.

The classroom we are assigned to is a computer lab and will have all the software you need for the course. However, we never know what will happen with COVID, and in the event that we switch to an online format, you will need your own computer to complete the remainder of the semester as well as the final project. That computer has to be something a little more substantial than a ChromeBook too because you'll need to download and run software. We'll cross that hurdle if we come to it.

# Course Purpose and Learning Outcomes

This course (and the MA program in general) is currently in a state of transition (and has been for a few years). The purpose of this course has changed along with it. Officially, the course description is this:

"Overview of, and experience in, research approaches and methodologies in linguistics and applied linguistics with a concentration on department faculty research interests."

#### Officially, the outcomes are:

- Understand the scientific method, why it is important, and how it relates to hypothesis testing
- Become familiar with different experimental methods as they apply to linguistics
- Be able to write a proposal to use human subjects in experiments (IRB)
- Be able to write a good conference abstract
- Be able to design and carry out experiments using software such as DMDX and Qualtrics

- Understand, and be able to use statistical tests such as correlation, t-tests, ANOVA, multiple regression, logistic regression, and chi square in SPSS
- Produce a draft of a thesis prospectus

However, despite the name of the course, it has shifted away from research methods. Anything having to do with experimental methods other than learning basic survey skills has been removed. Statistics are still present, and make up about a third of the lectures, although we will be using Jamovi instead of SPSS.

Instead, the course now places much more importance on the thesis prospectus. In fact, half of the lectures, and 100% of your grade will be related to your prospectus. By the end of the semester, you will pick a topic, choose a committee, read relevant literature, find out what methods you need to learn, write your prospectus, and do a mini prospectus defense for the class.

#### Classroom Procedures

This course will be taught more or less like two parallel courses. Tuesday's lectures will be related to the thesis prospectus. Thursday's lectures will be focused on research methods, most of which will be spent learning about basic statistics.

Instead of textbook-reading and quizzes, there will be two weekly expectations for students in this course. Homework assignments, which are due each Monday night, are related to the prospectus and culminate in the prospectus itself. Weekly meetings with your writing group to get feedback on recent progress towards finishing the prospectus.

**NOTE**: It is not technically required that you stick with the same thesis topic for the entirety of the semester. You are free to switch topics partway through. (In fact, whatever you turn in for this class doesn't even have to be related to the thesis you eventually write and defend!) However, homework assignments are due each week and the further into the semester you switch, the more catch-up you will have to play. It is worth it to put in the extra effort into choosing the right thesis topic early in the semester so that you can use the infrastructure, resources, and feedback available to you in this course to help you turn in the best prospectus you can.

# Assignments and Grades

Your grade will be determined based on the following assignments:

**The Thesis Prospectus (20%)** The purpose of this course is to turn in a prospectus,

so this single document makes up a large part of

your grade.

**Final Presentation (20%)** The purpose of the final presentation is to act as a

practice run for your actual thesis defense.

**Homework (40%)** There are approximately 12 homework assignments throuhout the semester.

Writing Group Meetings (20%) You will meet weekly with your writing group outside of class tp give feedback on each other's work.

Your assignments will be weighted accordingly and your final grade will be determined using the following table:

## Communication

The first injunction of the Honor Code is the call to "be honest." McKay taught that character is the highest aim of education" (The Aims of a BYU Education, p.6). It is the purpose of the BYU Academic Honesty Policy to assist in fulfilling that aim. ### Plagiarism

Intentional Plagiarism Intentional plagiarism is the deliberate act of representing the words, ideas, or data of another as one's own without providing proper attribution to the author through quotation, reference, or footnote. Intentional plagiarism is a form of intellectual theft that violates widely recognized principles of academic integrity as well as the Honor Code. Such plagiarism may subject the student to appropriate disciplinary action administered through the university Honor Code Office, in addition to academic sanctions that may be applied by an instructor. Inadvertent plagiarism, which may not be a violation of the Honor Code, is nevertheless a form of intellectual carelessness that is unacceptable in the academic community. Plagiarism of any kind is completely contrary to the established practices of higher education where all members of the university are expected to acknowledge the original intellectual work of others that is included in their own work. In some cases, plagiarism may also involve violations of copyright law.

Inadvertent Plagiarism Inadvertent plagiarism involves the inappropriate, but non-deliberate, use of another's words, ideas, or data without proper attribution. Inadvertent plagiarism usually results from an ignorant failure to follow established rules for

documenting sources or from simply not being sufficiently careful in research and writing. Although not a violation of the Honor Code, inadvertent plagiarism is a form of academic misconduct for which an instructor can impose appropriate academic sanctions.

Students who are in doubt as to whether they are providing proper attribution have the responsibility to consult with their instructor and obtain guidance. Examples of plagiarism include:

- *Direct Plagiarism*: The verbatim copying of an original source without acknowledging the source.
- *Paraphrased Plagiarism*: The paraphrasing, without acknowledgement, of ideas from another that the reader might mistake for the author's own.
- Plagiarism Mosaic: The borrowing of words, ideas, or data from an original source
  and blending this original material with one's own without acknowledging the source.
- *Insufficient Acknowledgement*: The partial or incomplete attribution of words, ideas, or data from an original source.

Plagiarism may occur with respect to unpublished as well as published material. Copying another student's work and submitting it as one's own individual work without proper attribution is a serious form of plagiarism.

## Respectful Environment

"Sadly, from time to time, we do hear reports of those who are at best insensitive and at worst insulting in their comments to and about others... We hear derogatory and sometimes even defamatory comments about those with different political, athletic, or ethnic views or experiences. Such behavior is completely out of place at BYU, and I enlist the aid of all to monitor carefully and, if necessary, correct any such that might occur here, however inadvertent or unintentional. I worry particularly about demeaning comments made about the career or major choices of women or men either directly or about members of the BYU community generally. We must remember that personal agency is a fundamental principle and that none of us has the right or option to criticize the lawful choices of another." President Cecil O. #### **Deliberation Guidelines**

To facilitate productive and open discussions about sensitive topics about which there are differing opinions, members of the BYU community should:

- 1. Remember that we are each responsible for enabling a productive, respectful dialogue.
- 2. To enable time for everyone to speak, strive to be concise with your thoughts.
- 3. Respect all speakers by listening actively.
- 4. Treat others with the respect that you would like them to treat you with, regardless of your differences.
- 5. Do not interrupt others.
- 6. Always try to understand what is being said before you respond.
- 7. Ask for clarification instead of making assumptions.
- 8. When countering an idea, or making one initially, demonstrate that you are listening to what is being said by others. Try to validate other positions as you assert your own, which aids in dialogue, versus attack.
- 9. Under no circumstances should an argument continue out of the classroom when someone does not want it to. Extending these conversations beyond class can be productive, but we must agree to do so respectfully, ethically, and with attention to individuals' requests for confidentiality and discretion.
- 10. Remember that exposing yourself to different perspectives helps you to evaluate your own beliefs more clearly and learn new information.
- II. Remember that just because you do not agree with a person's statements, it does not mean that you cannot get along with that person.
- 12. Speak with your professor privately if you feel that the classroom environment has become hostile, biased, or intimidating.
